We've expanded our concealed carry collection to include a variety of outerwear to meet all your needs, and hers too! Each piece is equipped with our patent-pending reinforced crisscross shoulder harness design with two strong Velcro® platforms to reposition your holsters for the perfect right or left hand draw.



WARNING:

Improper set up and positioning of all the parts could result in an unsecure firearm. To ensure security and a tight fit, follow these instructions to properly setup your concealed carry garment.






Legendary Whitetails Concealed Carry Firearm Sizing Template

- > Print on 8.5" x 11"
- > Unload your firearm
- > Place your firearm on the template
- > If your firearm fits* between the narrowest and widest outlines, your weapon could be a good fit in the holster.

*This template should be used to estimate if your firearm will fit firmly in the holster, it does not guarantee a firm fit due to the variety of firearm brands, shapes and sizes.

STEP 1: UNLOAD FIREARM

To begin, ensure firearm is unloaded, double checking the chamber, and the safety is on.



STEP 2: REMOVE HOLSTERS

Remove both the left and right *holsters (A)* from inside of the garment. Lay the *holster (A)* of your choice (right or left side draw) on a flat surface.



HOLSTERS



FOR LEFT HANDED DRAW
PLACE ON WEARER'S RIGHT



FOR RIGHT HANDED DRAW
PLACE ON WEARER'S LEFT

STEP 3: REMOVE FRONT STRAP

Unsnap and remove the front *strap (C)* by inserting your finger in the front pouch to disengage the Velcro®.



STEP 4: REMOVE BACK STRAP

Remove the back *strap (B)* by inserting your finger in the back pouch to disengage the Velcro®.



STEP 5: PLACE FIREARM IN HOLSTER

Place unloaded firearm in the *holster (A)*. Make sure firearm is fully inserted.



STEP 6: SECURE FIREARM

While the firearm is inserted in the *holster (A)*, center the snap of *back strap (B)* on the upper part of the grip of the firearm. Wrap the strap over the firearm and while covering the Velcro® with your finger(s), push strap into back pouch. Press firmly to secure Velcro®.



STEP 7: CHECK BACK STRAP PLACEMENT

Fold *back strap (B)* over firearm and ensure snap placement.

IMPORTANT: Ensure the snap is centered and laying flat on the upper grip on the firearm. If placement of snap does not align and lay flat on the upper grip, repeat step 6.



STEP 8: ATTACH FRONT SNAP

Securely snap the *front strap (C)* on to *back strap (B)*.



STEP 9: ENSURE SNUG FIT

With your finger covering the Velcro® of the *front strap (C)*, slide the *front strap (C)* into the pouch until both straps are tight against the firearm. As you remove your finger, press down firmly to secure the Velcro®.



IMPORTANT

STEP 10: ENSURE SECURITY

The snap should be secure and centered and lay flat on the upper grip of the firearm. The straps should be tight and secure just under the tang of the firearm. If the straps are too loose, the firearm will shift in holster. If the snap is not correctly centered and flat on the upper grip of the firearm, it could cause the snap to unfasten. Repeat step 6-10 if needed to readjust *straps (B)* and *(C)* to properly secure the firearm.



STEP 11: HOLSTER PLACEMENT

Put on your Legendary Whitetails Concealed Carry garment. Place the *holster (A)* on the appropriate side (Left or Right draw) in your preferred position. Press the *holster (A)* onto the Velcro® *platform (D)*, assuring that the Velcro® is fully engaged.



STEP 12: SECURE HOLSTER

Take off the garment and lay it on a flat surface. Press down on the *holster (A)* against the Velcro® *platform (D)* to ensure it is secure to the inside of the garment.



STEP 13: RELOAD FIREARM

To reload your firearm, unfasten the *holster* (A) and fully remove the firearm. Reload your firearm and place it back into the *holster* (A) and fasten the snap securely.

Use Instructions:

This product allows you to adjust the holster position. Adjust holster position to your personal preference only with the single firearm you select to fit properly in the holster. Ensure the firearm is unloaded when selecting your best fit.

Ensure Velcro on holster is fully attached to Velcro on garment. Do not attach unless holster Velcro is 100% attached to garment Velcro.

After your best position is determined, fully press the empty Velcro holster attachment firmly to the garment to secure it completely to the garment Velcro.

Discard holster: if strap snap or holster is worn, loose, broken, ill-fitting or damaged; or if Velcro on vest or holster becomes contaminated with any dirt or debris.

Check local and state law before using vest to carry a firearm. Make sure you have proper licenses and training required. It is solely the Purchaser's responsibility to ensure compliance with any and all such laws or regulations before use.

KNOW YOUR FIREARM COMPLETELY. DO NOT USE THIS VEST WITH ANY FIREARM THAT IS NOT PROPERLY MAINTAINED. CONFIRM YOUR FIREARM FITS PROPERLY AND SECURELY IN VEST. SRI STRONGLY RECOMMENDS YOU SELECT A SINGLE FIREARM TO USE WITH EACH HOLSTER.

OBTAIN FULL FIREARM TRAINING BEFORE USE. Legendary Holdings, LLC strongly recommends the Purchaser obtains training from a certified firearm use and safety instructor as well as practice routine use with an unloaded weapon. The purpose of this is to ensure the Purchaser is familiar with their firearm and the holster as well as the proper use and techniques involved with using a firearm.
